FLY FOR FUN TERMS AND CONDITIONS

Points

1. Points accrued in a Fly for Fun Rewards Account ("FFF Account") may be redeemed provided all of the customer's Colt International Accounts are in good standing and not cancelled or terminated by Colt International or the Customer (except as provided below), at the time of the redemption request. If any Colt International Account is not in good standing, the Customer's enrollment in the Fly for Fun Rewards Program, ("FFF Program") may be cancelled or points accrued in the FFF Account may be forfeited.
2. Each Customer enrolled in the FFF Program will accrue one point in their FFF Account for virtually every one gallon delivered FOB into the Customer's aircraft and charged and billed on the Customer's Colt Card account provided such charges are paid according to terms. Invoices paid late will render all eligible points on that invoice forfeited. Bulk deliveries and special pricing contracts are not eligible under the FFF Program.
3. The Customer will not accrue points in their FFF Account for any service or fueling provided prior to the enrollment date.
4. Once accrued points in a Customer's FFF Account have been converted into a Reward, the points cannot be converted back into the Customer's FFF Account.
5. Credits posted to a Customer's FFF Account, including those arising from returned goods or services, will reduce the points accrued in the Customer's FFF Account.
6. If a credit posted to any of the Customer's Accounts reduces the FFF Program account balance below the minimum required to redeem a Reward, Colt International reserves the right to decline the Customer's request to redeem a reward.
7. Points accrued in any FFF Account do not constitute property of the Customer and are not transferable by operation of law or otherwise to any person or entity and cannot be transferred to any other FFF Account.
8. Points accrued in a Customer's FFF Account will be carried forward for a period of two years, provided all other conditions set forth herein have been met. Points will expire after two years from the date the points are added to the Customer's FFF Account.
9. If for any reason Colt International cancels any FFF Account, any points accrued in the FFF Account(s) will be forfeited.
10. If a Customer cancels a FFF Account or cancels all Colt Cards from Colt International, all points accrued in the FFF Account will be forfeited immediately.
11. If a Customer has more than one FFF Account enrolled in the FFF Program, voluntarily cancels any such FFF Account, and keeps at least one FFF Account enrolled in the FFF Program, any points accrued in the cancelled FFF Account may be transferred to any remaining FFF Account that continues to be in the FFF Program, provided all other conditions set forth herein have been met.

Certificates

1. Gift Certificates are valid at participating merchants only, through the expiration date printed on the certificate.
2. Fulfillment of the Gift Certificate(s) is the sole responsibility of the merchant, not Colt International.
3. Certificates are not valid toward previous purchases, and cannot be used as payment on existing account balances with either the participating merchant or Colt International.
4. Certificates have no cash value and may not be redeemed for cash or its equivalent, and any unused portion will not be returned as cash unless a certificate states otherwise.
5. Certificates are not transferable unless otherwise noted on the certificate.
6. Expedited delivery of a certificate is available upon request. There is a fee associated with this service.
7. Certificates are void where prohibited by law.
8. Unless otherwise stated on the certificate, certificates offered do not include any federal, state, or local taxes, which are the sole responsibility of the Customer.
9. Use of any certificate is subject to any additional restrictions listed on the certificate or as specified by carrier.

General

1. The request for conversion of points from the Program for redemption must be made by the Member listed on the Account. Requests for Reward Redemptions must be initiated by contacting Colt International.
2. Fraud or abuse relating to the accrual of points or redemption of Rewards may result in forfeiture of accrued points as well as cancellation of a Customer's Program Account and any Colt International Card account.
3. All accounts must be billed in U.S. dollars to be eligible for enrollment in the FFF Program.
4. All questions or disputes regarding eligibility for the Program or the eligibility of points for accrual or redemption of points will be resolved by Colt International at its sole discretion.
5. The determination of tax liability for any federal, state, or local taxes, as may be applicable, arising out of the accrual of points or redemption of points in the Program, shall be the sole responsibility of the Customer.
6. Colt International is not responsible for typographical errors and/or omissions in this terms and conditions.
7. These terms and conditions are governed by and construed under the laws (excluding conflicts of law provisions) of the State of Texas.
